AGREEMENT TO SCHOOL A HORSE AND SELL ON BEHALF

Jody Hartstone of Karioi Sport Horses, Raglan agrees to take the above mentioned horse for schooling and sale on behalf noting the following conditions:

1. The price for schooling is to be \$250 (incl GST) per week.
2. This price includes grazing, but hard feed, hay and supplements if required will be billed out to the owner of the horse.
3. Stabling (if required) is at an additional cost of \$50 (incl GST) per week to cover stall clean out and bedding.
4. Shoeing costs will be billed to the owner.
5. Any veterinary expenses incurred with this horse whilst on the property of Karioi Sport Horses will be billed directly to the owner of the horse
6. The horse will be advertised by Jody Hartstone when she feels the horse has become a saleable prospect. Advertising costs will be billed to the owner.
7. The first payment of one months schooling fees is payable in advance.
8. An invoice will then be posted to the owner of the horse at the end of every month and will be due for payment within seven working days.
9. If the owner wishes that the horse be competed at dressage shows, any costs involved eg entry fees and diesel will be at the expense of the owner.

10. The horse will at all times be available for sale at a price mutually agreed upon between Jody Hartstone and the owner.
11. It is accepted that Jody Hartstone will charge a 10% commission (plus GST) on the sale of any horse brought in for schooling.
12. The owner has the right to terminate this agreement at any time if in their opinion the health and welfare of the horse is being compromised by the implementation of the agreement, however outstanding fees must be paid in full.
13. Jody Hartstone has the right to terminate this agreement at any time and to send the horse back to the owner.
14. It is the owner's responsibility to keep an up to date insurance policy for the horse whilst it is in the care of Karioi Sport Horses.
15. Karioi Sport Horses and Jody Hartstone will not be held responsible for any injury, illness or death to the horse whilst in their care.
16. Any money owing to Jody Hartstone and Karioi Sport Horses must be paid by direct credit / bank cheque or cash before the horse is removed from their care. By signing this agreement the owner agrees to give Karioi Sport Horses a legal lien over the horse, until any outstanding amounts are paid in full. It is understood that in the case of non-payment of accounts that interest of 10% p.a. will be payable, and / or the horse may be sold to defray costs.
